## 1. Call to Order:

The meeting was called to order at 3:00 p.m. by Chairman Paige.

# 2. Approval of the Minutes of the December 26, 2017 Board Meeting Minutes:

Chairman Paige and the Executive Director had a telephone conference with Jennifer Gottlieb Elazhari, CT Public Housing Director in Hartford and it was agreed to have 8 ADA units designated as non-elderly.
