1. Call to Order:

The meeting was called to order at 3:00 p.m. by Vice-Chairman Kelsey.

In attendance were: Vice Chairman Neil Kelsey, Commissioner Joseph Lemelin, Commissioner Sally Mangione, Resident Commissioner Betty Button, Linda Groppo, Board Liaison and Executive Director, Jayne Martigneni. Absent: Chairman Anthony Paige.

2. Approval of the Corrected Minutes of the Regular Board Meeting of February 25, 2019:

A Motion to adopt the corrected minutes, of the February 25, 2019 Board Meeting, was made by Commissioner Lemelin, Seconded by Commissioner Button. All were in favor.

3. Report of Financial Budgets/Statements for March 31, 2019:

The Executive Director explained that the budget exceeded the budgeted amount for line item 4430.25, Unit Turnaround, at Chestnut Grove in the amount of \$2,313.00 due to the excessive amount of vacancies.

The Executive Director explained that the amount exceeded the budgeted amount for line item 4430.25, Unit Turnaround, at Greenwoods Garden South in the amount of \$1,589.00 due to the excessive amount of vacancies.

A Motion was made by Commissioner Lemelin, Seconded by Commissioner Mangione to accept the Financial Budget/Statements for March 31, 2019. All were in favor.

4. Report of Financial Budgets/Statements for April 30, 2019:

The Executive Director explained that the budget exceeded the budgeted amount for line item 4430.25, Unit Turnaround, at Chestnut Grove in the amount of \$4,509.00 due to the excessive amount of vacancies.

5. Report of Greenwoods Gardens (E-72/14 units) Interim Statement of Operations for the nine month period ending March 31, 2019.

The Vacancy loss is higher due to the eviction that took place at Greenwoods Garden North (E-72).

18. Adjournment:


